Agenda Trustee Sponer moved to approve the Agenda as proposed. There was

New Business (Item III.)

Committee members agreed to hold their next meeting prior to the April Board meeting. Regular Board meetings would continue to be held on the second Thursday of each month, except for the May meeting, which will be held on the third Thursday of that month.

Executive Director Walters updated the committee with a report of his meeting with Mesquite Mayor Bill Nicholes regarding a new Mesquite library, his conversation with North Las Vegas Library Director Anita Laruy about rejoining the District's on-line system, a delay in the West Las Vegas Library Homework Help Center and efficiency remodel, updated consolidated tax (CTX) revenue projections and the details of a budget augmentation request.

The upcoming Legislative Session in Carson City was discussed and potential legislative issues such as North Las Vegas' desire for a redistribution of CTX revenues were reviewed. Mr. Walters said all recipients of CTX revenues resisted any change to the funding formula in the last two legislative sessions. A possible bill in the upcoming session would freeze redistribution of the CTX for a period of years.

The legislative client list of District lobbyist Robert Crowell's firm, Kummer Kaempfer, was passed out to committee members. Mr Walters reviewed the District's history with Mr. Crowell.

No action was taken at this meeting.
