Ms. Ford reported that PBTK has completed their annual audit of the District for the year ending June 30, 2017 and have issued their Audit Opinion which is included in the Financial Report document and their report on the District's internal controls. PBTK has also issued their Required Communications Letter.

Trustee Moulton asked about a statement on page 37 of the Annual Financial Report about the Las Vegas-Clark County Library Foundation, Inc. (Foundation) being included in the District's annual financial statements as a component unit going forward. Trustee Benevidez, as a Foundation Board member, said that the Foundation does have an annual audit. Mr. James said that the Foundation has always had an audit since it was created in its current form. In addition to the Foundation's financial statements being included, James said that each QUALICB that the Foundation sets up, for East Las Vegas and Mesquite,
