# DECEMBER 9, 2021 MEETING OF THE BOARD OF TRUSTEES' BYLAWS COMMITTEE

#### Agenda Item #IV.A.:

Discussion and possible Committee action to recommend adding a new Article to the Library Board of Trustees Bylaws and Policies:

"Current and former members of the Board of Trustees may not apply or be employed by the Las Vegas-Clark County Library District as either a direct employee or contractor for a period of 12 months following the end of their service on the Board."

#### Background:

Trustee Nathaniel Waugh has requested an agenda item to amend the bylaws as written above.

Nevada Revised Statute 281A.010 states, in part, "It is hereby declared to be the public policy of this State that: (a) A public office is a public trust and shall be held for the sole benefit of the people." And "The Legislature finds and declares that: (a) The increasing complexity of state and local government, more and more closely related to private life and enterprise, enlarges the potentiality for conflict of interests. (b) To enhance the people's faith in the integrity and impartiality of public officers and employees, adequate guidelines are required to show the appropriate separation between the roles of persons who are both public servants and private citizens."

This bylaw amendment seeks to reaffirm the Las Vegas-Clark County Library District Board of Trustees' commitment to the ethical performance of their duties free from conflicts of interest and to prevent any use of our public office for personal gain or career advancement. Other agencies, such as the Clark County Board of School Trustees and the Nevada State Legislature have similar "cooling-off" periods.

"Any member of the Board of Trustees may cast a proxy vote in officer elections in the event of their excused absence. Members shall submit, in writing, their intended proxy vote to any other member of the board to be entered into the record."

#### Background:

Trustee Jose Melendrez has requested an agenda item to amend the bylaws as written above.

The existing bylaws require officers of the Board of Trustees be elected during the June meeting. The bylaws of the Board of Trustees also allow for Trustee absences with certain limitations.

This item would allow trustees with proper notice to cast a vote for Chair, Vice Chair, Secretary and Treasurer via proxy in a manner detailed in the proposed amendment.
